Agra: Heavy rains lashed Mainpuri for several hours on Thursday leaving three children dead and several others injured in separate incidents of wall collapse.

In the first incident, the wall of a temple fell on three children near a primary school in Dostpur village while they were on their way home from coaching class. Two of the children, Nisha (9)

Mainpuri, killing a 10-year-old girl, Shilpi. According to sources, the incident occurred when she went to relieve herself.

Meanwhile, a 10-year-old woman, Anaridevi, was killed in another incident of wall collapse at Saralage of Mathura.
