## Bed scam: SIT to 30 guilty during '0

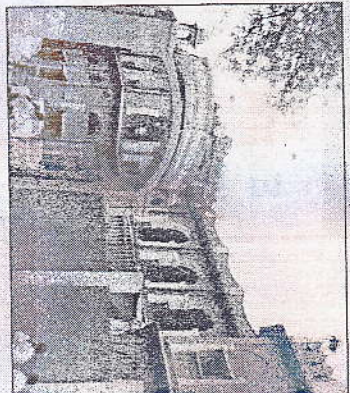
Agra: The special investigation team (SIT)'s report of the Bed scam during the 2004-05 academic session in Dr BR Ambedkar University has found 30 erring officials, many from the varsity's examination cell, informed sources. The SIT officials are likely to visit the varsity for their final interrogation process sometime this month.

The university had declared results of 12,500 candidates for the 8,500 Bed seats during 2004-05 academic year. An SIT report last year had found 5,332 fake Bed mark sheets out of the total 8,000 issued during that session. Sources also said that, on the basis of fake mark sheets, 2,510 fake Bed degree holders were appointed as teachers in government-run schools.

"During investigation it was found that marks in around 2,000 mark sheets were more than those awarded in the answer sheet. In these cases marks were increased after the evaluation
