Van Rawats ready to vote for those giving food

Continued from p1

To Kimpeta has come to our village Kimkhola asking for votes. But, people in our village know that voting is going to happen soon. Most of us will simply vote for whoever gives us food and provisions," said Parvati, a Van Rawat woman who had come to sell firewood collected from the jungle at the Jauljibi market near Dharchula. Another woman, Vinila, who had accompanied her, reiterated, "People of our tribe are extremely poor. Most of us barely manage to earn Rs 80 or 100 per day. That is why, whoever gives us food or money, we go along with him."

The origins of the tribe - which has had a close association with mountain jungles - are not very clear. According to Dehradun-based anthropologist Lokesh Ohri, folklore has it that the tribe is descended from royalty. "Van Rawats are believed to be the descendants of a king who ruled at Askot near Pithoragarh. It hasn't been historically proven but the story is that one of the king's brothers was exiled from the kingdom and went to live in a cave. His descendants became the Van Rawats. They consider themselves as Rajputs and according to those who

have lived and interacted with them insist on being addressed respectfully in accordance with their lineage. Because of living in the jungle, the community has not had much access to education and employment opportunities. According to Renu Thakur, a member of the NGO Arpan, which works for the tribe, Van Rawats have since decades, started living in pucca and taken to working but still don't have a permanent source of income. "They are usually employed for road construction under the MNREGA scheme. The Border Roads Organisation (BRO) also employs them for agricultural work. Since the small community and have no big thing to elevate their status."

Incidentally, Gagan Singh Raj, a member of the tribe, had won the Dharbhadra seat in 2002 and 2007. The Dharbhadra seat was made vacant by the death of the incumbent, who went to school, says that the tribe is "very simple and poor and has been able to speak up for themselves. Most of our people are simply the making ends meet. They do not take interest in politics."
