Sub: Report on electronic voting carried out during 26th day of September, 2023 (09.00 A.M.) to 28thday of September, 2023 (05.00 P.M.) and Poll conducted at the 51th Annual General Meeting of INDU ENGINEERING AND TEXTILES LIMITED held on 29th September, 2023.

- I, Anuj Ashok, in the capacity of the Scrutinizer, furnish the consolidated report asunder:
- 1. The Company engaged the services of Central Depository Services of India Limited (CDSL) (hereinafter referred to as the "Service Provider") to offer the e-voting facility to its shareholders. The e-voting facility was offered and kept open by the Company to its Shareholders for the period commencing on 26th day of September, 2023(09.00 A.M.) and ending on 28th day of September, 2023(05.00 P.M.). At the 51th AGM of the Company held on Friday, the 29th day of September, 2023, at 03:00 P.M. at Registered Office of the Company situated at 12/16-A Nawal Ganj, Nunhai, Agra- 282006 a Poll was conducted on all the resolutions to facilitate the members present at the meeting, who did not participate in the e-voting to cast their votes through the poll.
 - 3. Further, ballot box was locked and sealed by me in the presenceof the members and the proxies. Subsequent to the completion of polling process, both the ballot (polling) boxes were unlocked by me in the presence of Mr. Vinod Kumar Sharma and Mr. Virendra Niwas Khaitanand the poll papers were diligently scrutinized by me. The poll papers were reconciled with the records maintained by the Company / Registrar and Transfer Agents of the Company and the authorizations / proxies lodged with the Company.
